I. Call meeting to order

a. Roll call.

Meeting was called to order by Miguel Figueroa at 2:04 p.m. Roll call was performed by Esperanza-Colio Warren with four (4) JPA members present; it was determined that quorum was

met. Rosanna Moore and Romualdo Medina participated in the meeting via telehone, with the appropriate posting of the agenda of the meeting.

b. Approval of 12/13/2017 minutes.

Miguel Figueroa motioned to approve minutes as presented, Andy Horne 2nd. **Vote:** 4 in favor, 0 against, 0 abstain at the time of the vote. **Motion passed**.

II. Discussion/action

a. Update on IVFTZ operator collections effort – Pimentel Case.

A discussion regarding the delinquent account status of Margarita Pimentel FTZ Operators and numerous attempts to contact her regarding her fees and late report with the FTZ. A. HORNE recommended sending her a 30-day notice letter stating that her operator status will be terminated due to non-payment of fees. D. HARLOW mentioned she did not have any activity for the year of 2017. It was recommended sending her a letter regarding her delinquent status and failure to non-payment will result in cancellation of operator's agreement and inform US Customs regarding her status. A. HORNE motioned to send the letter to Ms. Pimentel giving her a 30-day notice to pay: 4 in favor, 0 against, 0 abstain at the time of the vote. **Motion passed**.

b. Pending discussion from NAFTZ annual conference experience.

A. HORNE emphasized that there were some members pending to share their experience from the NAFTZ from the previous FTZ meeting. M. PIEDRA provided her feedback by talking about the sessions she attended, which focused on how to target and promote the FTZ. Members discussed what does the current FTZ has available and how is being promoted to the public. E. COLIO-WARREN suggested identifying companies, who are importing and exporting products. After identifying them, follow up with them via e-mail or telephone. Lastly, visit them and inquire if they are interested in being part of the FTZ. D. HARLOW recommended starting targeting agencies, providing seminars and/or presentations to promote the FTZ.

c. Ratification of Foreign Trade Zone annual report.

D. HARLOW explained the annual report showed a beginning balance just over 1.5 million dollars in 2017, and there was over 150 million dollars worth of goods that came into the zone. Approximately, that same amount left the zone, leaving a balance of 1.1 million of dollars in the FTZ throughout the year. Coppel Corporation represented 113 million in goods activity, JE Exports 2 million in goods activity, My Distribution Center and Warehouse Bonded Services had no activity for the year of 2017. A. HORNE suggested discussing the status of My Distribution Center with the FTZ. M. FIGUEROA motioned to ratify the Foreign Trade Zone annual report, 1st by A. HORNE, 2nd by M. PIEDRA. Four (4) in favor, 0 against, 0 abstain at the time of the vote. **Motion passed**.

Upon review of your file, it has come to our attention that you are currently delinquent in the following element required by Imperial Valley Foreign Trade Zone (IVFTZ) #257 Operators:

• Fiscal Year 2017-18 Operator Fees in the amount of \$5,000.

Our records indicate that you have failed to meet the abovementioned requirement. Our office and associates have repeatedly attempted to contact you and your office by telephone, email, and mailing correspondence regarding your delinquent status; our efforts have been unsuccessful. Per the direction of the IVFTZ – JPA Board, failure to pay your delinquent fees within 30 days from the date of this letter will result in initiating the process of cancelling your operator's agreement with the IVFTZ #257. The initiation to cancel your operator's agreement will include notification to the U.S. Customs of your status to start your deactivation process with the IVFTZ # 257.

This letter is in reference to the letter you received from CBP on November 25, 2016 regarding the security standards required for CBP Bonded Facilities. Upon review of your file, it has come to our attention that the facility is not in compliance for the following reasons:

- Facility is without proper lighting.
- Facility's building is made out of old thin sheet metal.
- Floor is in unsanitary conditions.
- Lack of cameras and alarm system.

Our office and associates are interested in knowing the actual status of your facility. The facility must meet the security standards required from CBP to be in compliance. Please be aware that it is imperative to address the aforementioned issues to be able to operate as a FTZ operator. Should you wish to operate under the IVFTZ umbrella, all the issues mentioned above must be addressed.

Furthermore, we would like to take this opportunity to invite you to our next Foreign Trade Zone meeting, which will be taking place on May 23, 2018 at 383 Main Street, Brawley CA, 92227.

IVFTZ Marketing Plan for Internal Promotion.



MARKETING PLAN

Summary:

The purpose of this Strategic Marketing Plan is to supplement the Grantee's responsibility to proactively promote and expand the Foreign Trade Zone Program within the Grantee's zone project. The promotion and marketing of the Foreign Trade Zone Program, and International Trade has many facets to consider. *Name Affiliation*- Providing knowledge and awareness of the Grantee, the Foreign Trade Zones Program, and outlining the benefits and advantages of becoming an FTZ will help in securing leads and prospective business. Communicating and promoting to target the various types of business owners in the area is critical to the success of FTZ marketing. This includes breaking up the facets (levels) of marketing to determine where the most effective and cost balanced campaign for FTZ attraction should be structured. *Local, State, National, and Global Marketing* has specific levels of accomplishments, timelines, and associated costs. Properly understanding these concepts along with their benefits and risks are vitally important when developing a marketing agenda to create local jobs and economic stimulation.

Name Affiliation:

The Foreign Trade Zone Program is typically geared towards International Trade Logistics Hub businesses that are savvy with the concepts of International Trade, Import/ Export, etc. One of the primary goals of the Grantee is to provide education to all local businesses. For more than five years Imperial Valley has grasped the natural resources attributed to its location. These resources include but are not limited to: a strategically located region that borders our largest trade partner, water supply, an alternative energy environment, and a strong/educated labor force. These resources have collaboratively been used to establish name affiliation with one of America's Gateways to Mexico for international trade. The FTZ program has created awareness locally; however, FTZ awareness is still murky Statewide, Nationally, and Globally. As this is a process, it is important that this name affiliation with Foreign Trade Zones becomes aggressive locally and is prioritized at minimum statewide and nationally. Efforts such as the Cali-Baja program and others are a great start--but just a start.

Local Marketing:

With marketing material and a logo for branding opportunities available, we can now utilize County and City data bases to identify business that can potentially benefit from the FTZ Program. Working with Chambers of Commerce and reaching out to neighbors in Mexicali is another inexpensive way to educate the business community. Partnering with other government programs such as the State Tax Incentive Program. CITD, SBDC, DOC, etc. are other inexpensive paths that will only require investment of time. I recommend a sub – committee to bring these local resources together to expand on these local opportunities. Additionally, meeting with local communities to develop strategies that are aligned with successful approaches to small, medium, and large business is vital to the effectiveness of marketing the FTZ Program. Fiscal impact: minimal funding upon utilization of sponsorships and local government support. Fiscal Benefits: sustainable job retention and job creation.

Conclusion:

There are many ways to properly market International Trade and the Foreign Trade Zone in Imperial Valley. The cost for the plans will vary due to the size of the scope, but as identified, it is not always spending the money but creating uniqueness that sets your region apart from the balance. This applies to local, state, national, and global awareness. As expressed in the talking points of the FTZ Program, thinking outside the box and using creativity will allow your return on your investment to be limitless. Understanding and utilizing your available resources to



implement a productive marketing plan that will accommodate multiple industries is vital to the success of this project for years to come.

The Imperial Valley Foreign Trade Zone – Joint Powers Authority (IVFTZ-JPA) and ITC-Diligence entered into an Agreement for Services dated June 1, 2009 ("Agreement").
